- Please have students bring a reusable water bottle or be sure to bring enough water for students and staff. We will provide water stations so that students can refill water bottles.



Student Information

- 1. Have **both** parents/guardians sign and return the East Foundation release of liability form, East Foundation right of publicity, AND school permission slip. *Students will NOT attend the field day without turning in forms, no exceptions.*
- 2. Make sure to arrive at school early the day of the Field Day so that the school can leave on time.
- 3. Check the weather forecast for **Port Mansfield, Texas** the day <u>before</u> the Field Day and dress for the weather. <u>Long jeans and closed toed shoes are mandatory</u>. Wear shoes that you don't mind getting sandy or wet. Hats are strongly recommended. Wear a jacket or sweater depending on weather or wear several layers to stay warm.
- 4. Apply insect spray and sunblock before you get to school do not apply these at school.
- 5. Eat a very good breakfast and use the restroom before leaving the school. It may be a long bus ride!
- 6. Students must follow all school rules at the El Sauz Ranch. Do not run and watch your step at the ranch.
- 7. If you need to use the restroom, let your teacher know. Students are not allowed to wander away from the rest of the group without permission.
- 8. Your campus will provide a lunch and the East Foundation will provide a water station to refill water bottles. *Be good land steward! Bring a reusable water bottle!* Your teachers will let you know if you may take snacks, extra drinks, or a lunch.
- 9. Electronics such as cameras, cell phones, tablets etc. may be used by students to take pictures IF your campus administration/teachers allow them.
- 10. Do not litter. Dispose of all trash in appropriate containers. We will be using portable restrooms, please be respectful and keep them clean. Only used toilet paper goes in the toilet.
- 11. The taking of animals or remains of animals and/or plants of any kind from the El Sauz Ranch is strictly prohibited. This includes feathers, bones, flowers, seeds, insects etc.
- 12. Always be respectful and attentive to all presenters during the Field Day and actively participate in discussions and activities.
- 13. You do not need to bring money with you, there is no gift shop or store.
- 14. Students must not bring any drugs, alcohol, vape pens, e-cigarettes, or illegal substances onto ranchlands.
- 15. All medication must be in the hands of school nurse and properly labeled (patient name, medication, dosage).
